



## **Activities Update**

### **Councillor Equality**

The NAC has been working on behalf of our Members' in relation to achieving fair and updated working conditions for Councillors' in Northern Ireland, as this topic has been a key point for debate at meetings both during, and prior to, the current term of office. We are pleased to announce that we have a meeting arranged to present our Members' views on this matter to the DfC Minister's Officials.

Also, the Clerk to the NI Assembly Committee for Communities' has advised that although the Committee are currently unable to grant us a meeting, they will consider a written presentation from the NAC.

A presentation is being prepared for both organisations with details of the issues that our Members have raised.

### **Councillors' Code of Conduct review**

The review is now making progress and the DfC published their response to the consultation on the revised Councillors' Code during December 2020.

The NAC are working with NILGA on preparing a reply to this, which will be sent to the DfC.

### **Partnership Panel**

Following our request, the DfC has granted permission for a representative from the NAC to attend future Partnership Panel meetings as an Observer.

We have been informed that we will receive an invite and papers for the next Panel meeting which is provisionally arranged to be held on 21 April 2021.

### **NI Public Service Ombudsman's (NIPSO) Office**

During January 2021 Cllr Joe Boyle, the NAC Secretary, circulated information to Members in relation to email correspondence that is sent to Councillors from the NIPSO office. This followed a request received from Mrs McAleer, the Acting Deputy Commissioner and included a letter that was sent to Council Chief Executives.

Following discussion by our Executive Committee, we have advised Mrs McAleer that it is the NAC's view that, due to the nature of this correspondence, it should be sent by letter direct from her office to the Councillor's home address, or to their Council address asking that they forward it on, as a matter of urgency and without any unnecessary delay, to the home address of that Councillor.

### **Condolences**

Were sent on behalf of the NAC to the President of the NAC UK, Cllr Marie Garrity when we received the sad news in December that her young brother had died having caught COVID-19. Cllr Garrity thanked the NAC Chair for our message.
